Upload CSV files for bulk verification processing.

3. Pricing and Payments

Verification cost: R0.50 per identity checked.

Bulk uploads are charged based on the number of records submitted.

Users may purchase credits in advance for use on the platform.

All payments are final and non-refundable unless otherwise required by law.

We reserve the right to modify pricing at any time with reasonable notice.

4. User Credits

Credits purchased are used to access verification services. All members will receive 3 free credit per day.

If credits are depleted, you must purchase additional credits to continue using the service.

Free account holders may receive limited complimentary credits at our discretion.

5. Prohibited Use



You agree not to:

Share or resell access to your account or verification results.

Use the service for unlawful, harmful, or abusive purposes.

Attempt to reverse-engineer, copy, or misuse our systems, data, or algorithms.
